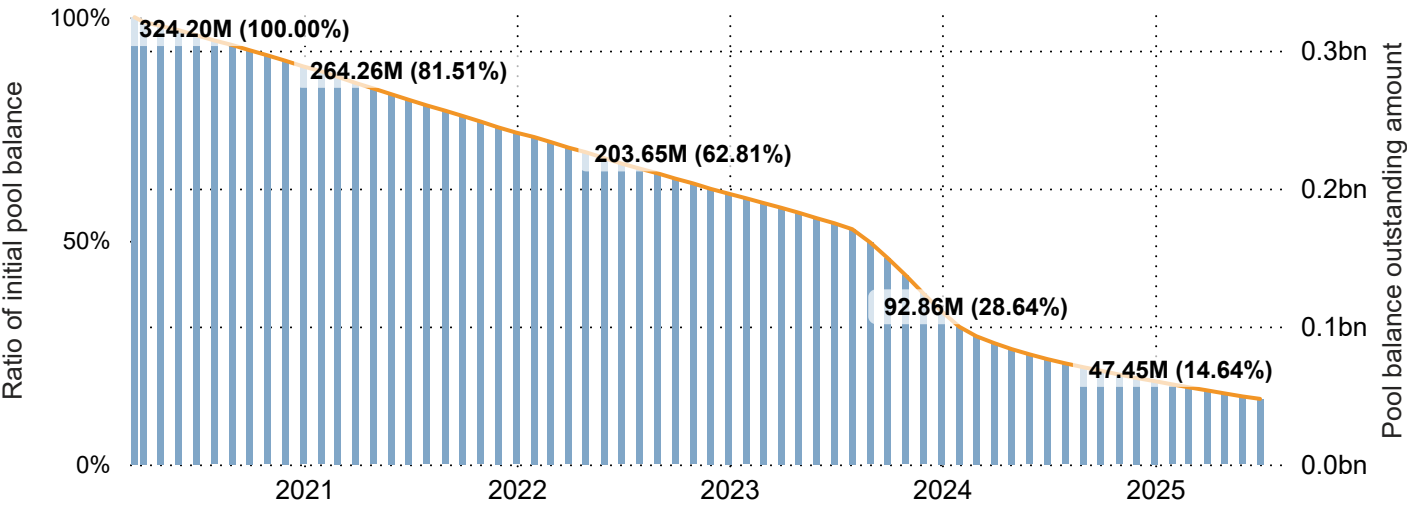

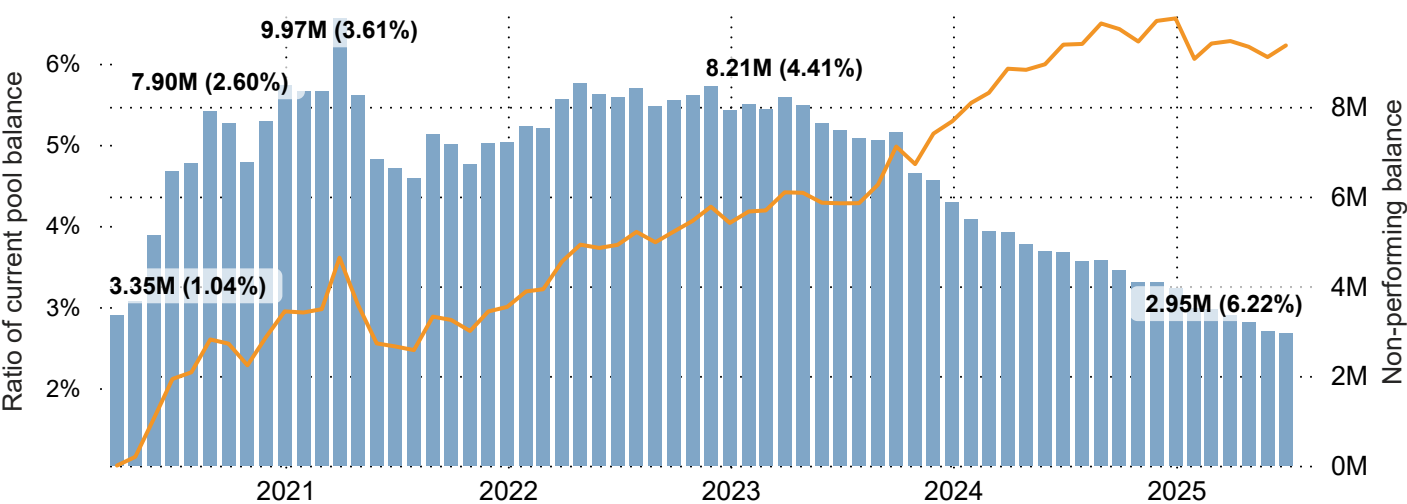
Asset pool balance (currency : EUR)

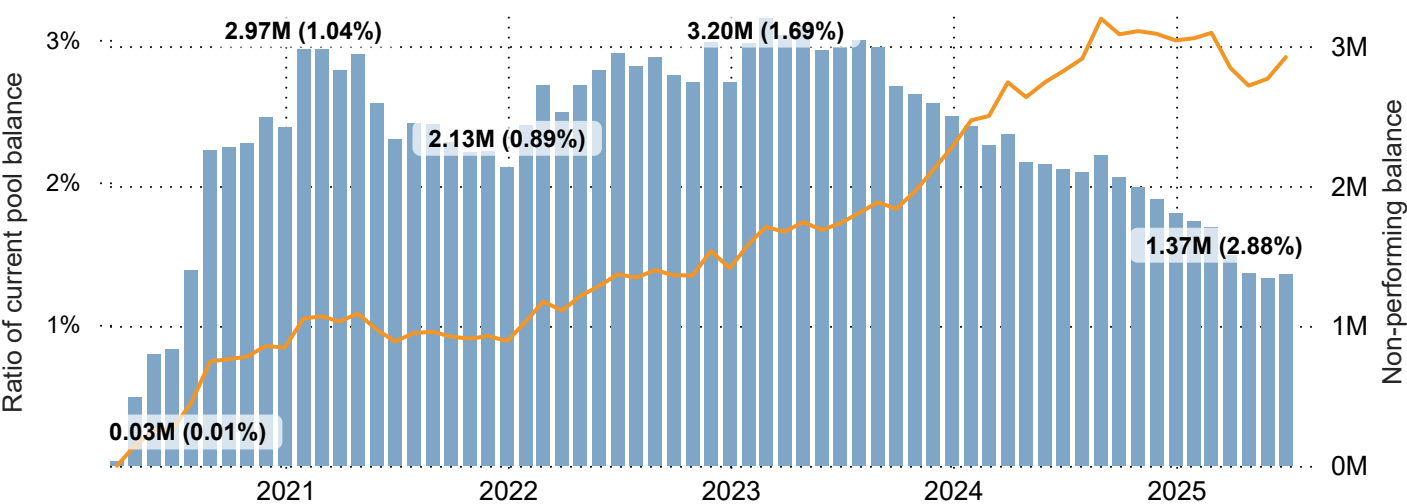
Non-performing balance due for more than 30 days in arrears (currency : EUR)

Non-performing balance due for more than 90 days in arrears (currency : EUR)

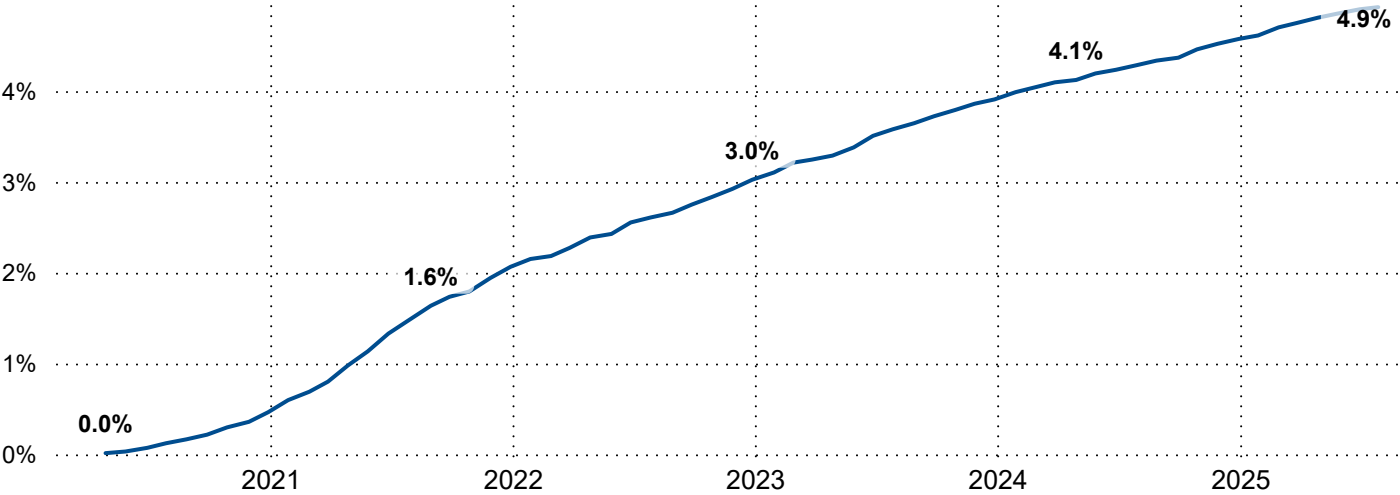

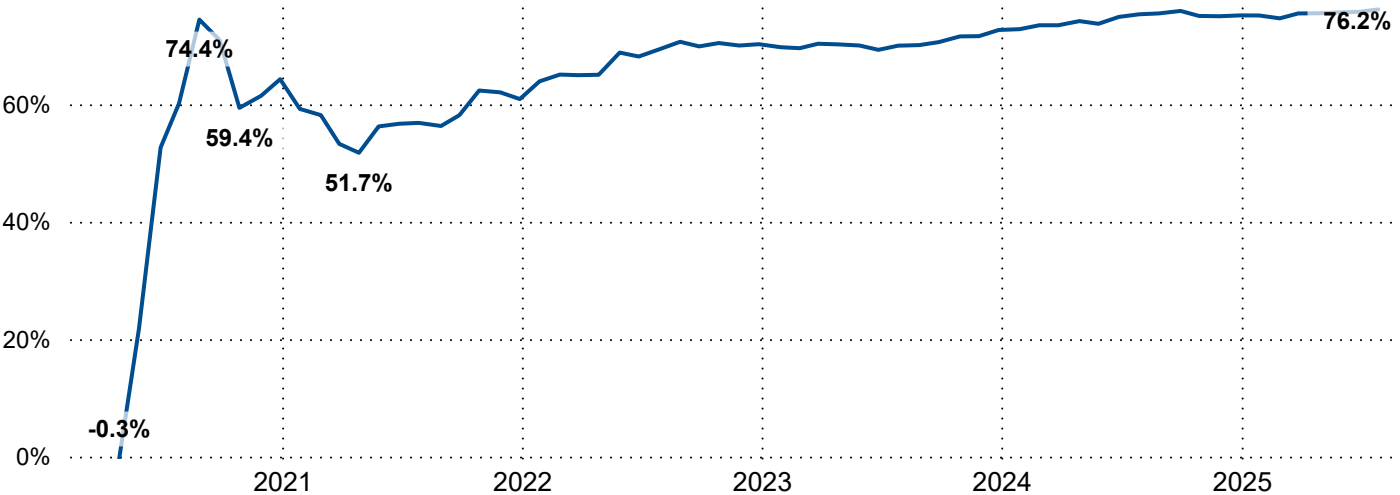
Cumulative default ratio (default : 8M)

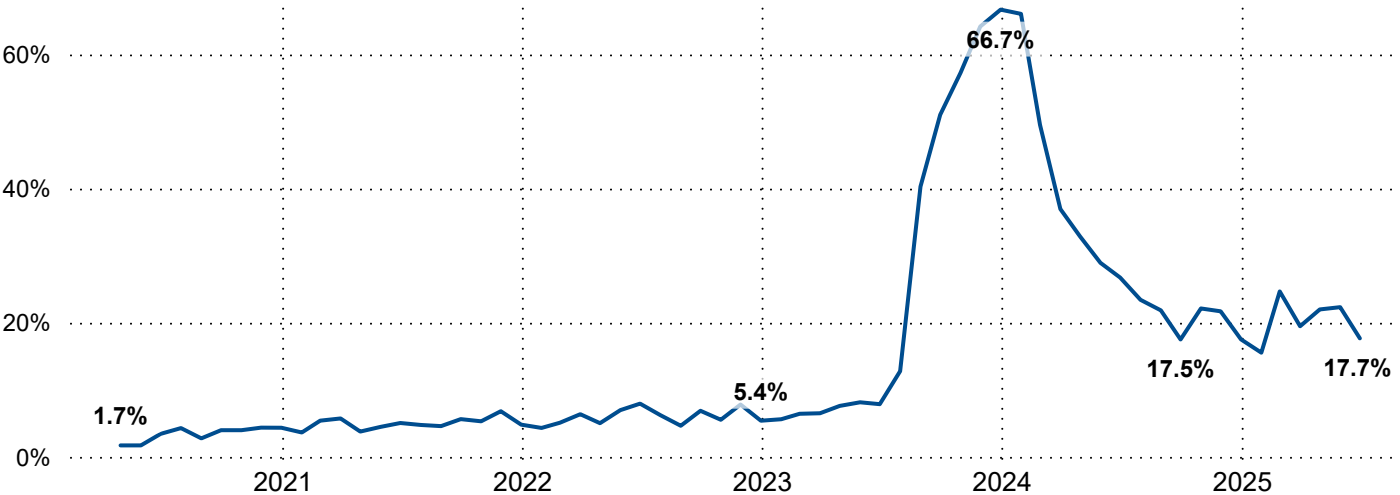
Cumulative recovery ratio (default : 8M)

Annualised constant prepayment rate (CPR)

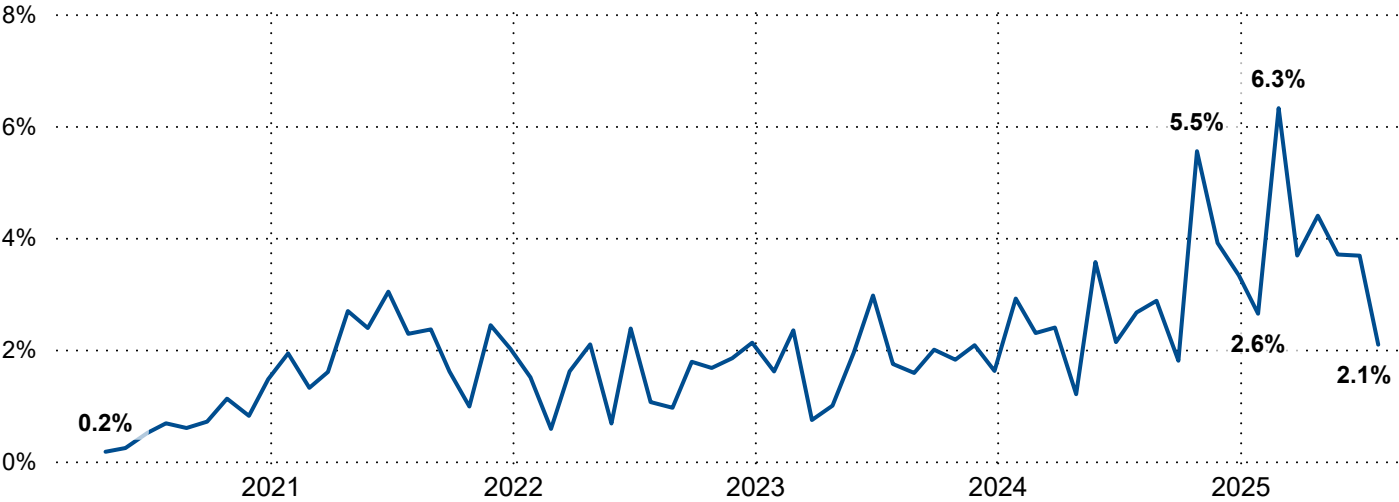

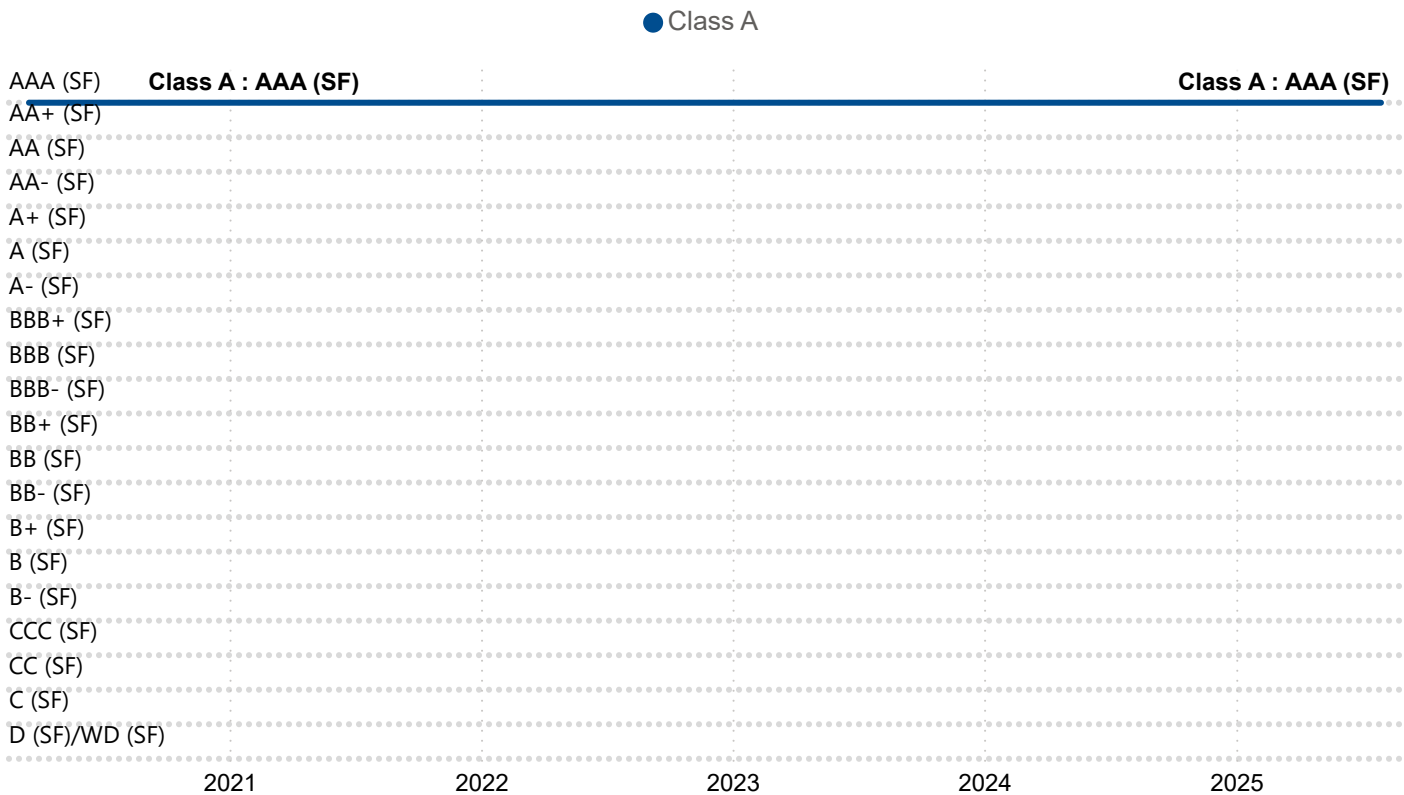

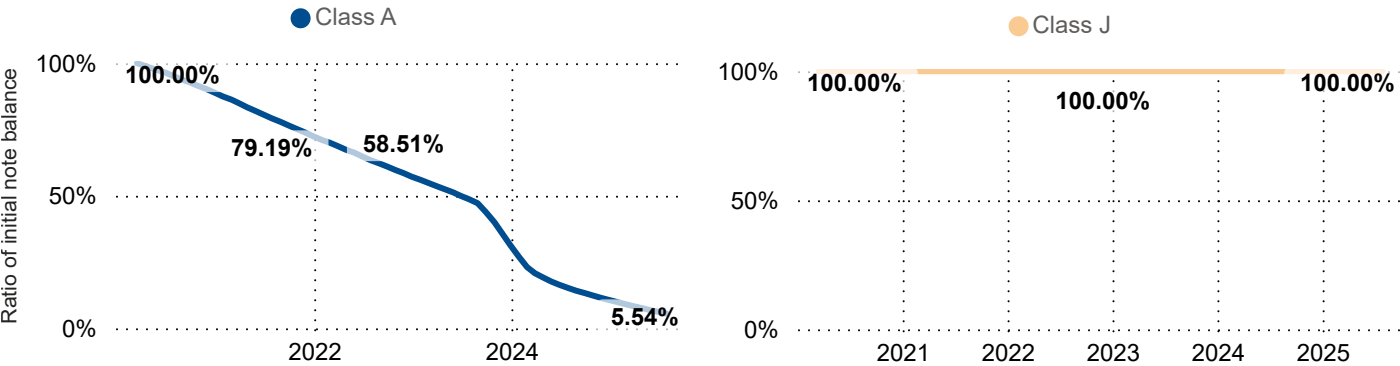

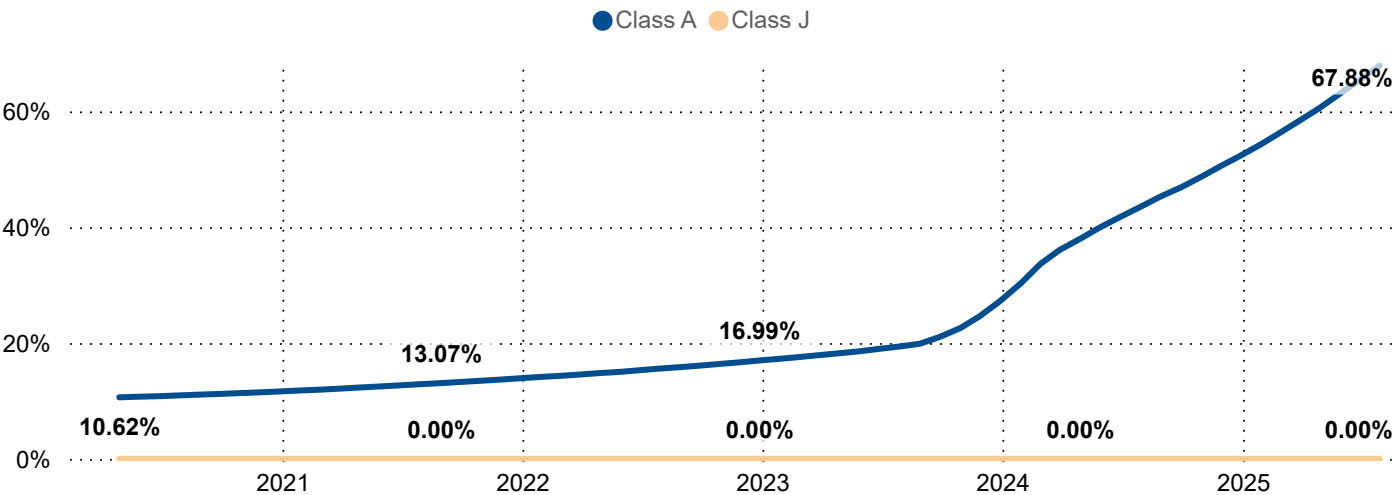
Outstanding notes balance

Credit enhancement

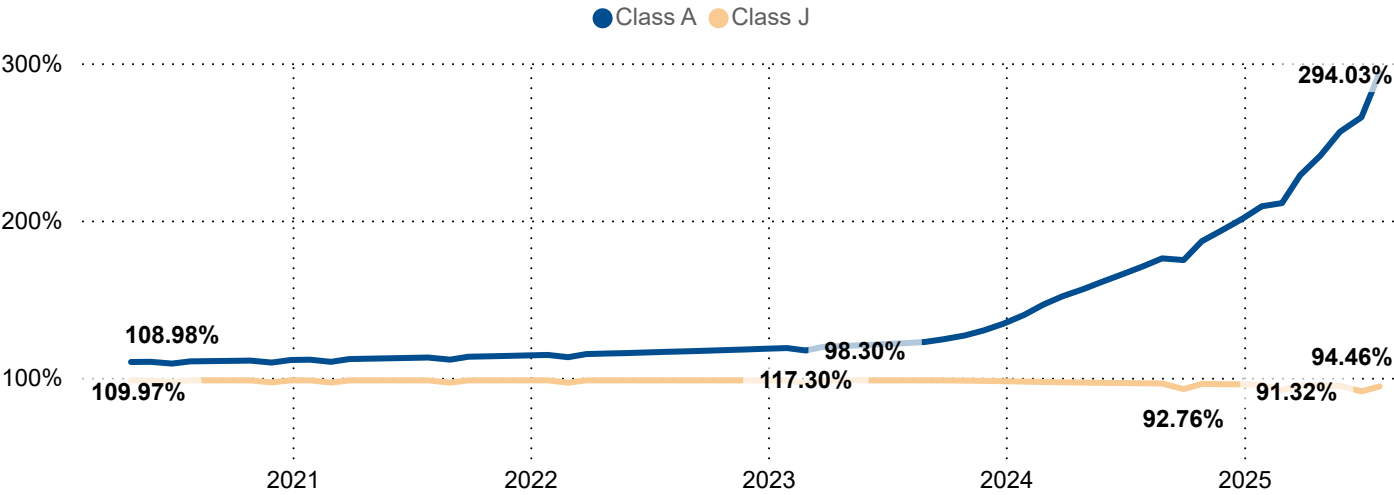
