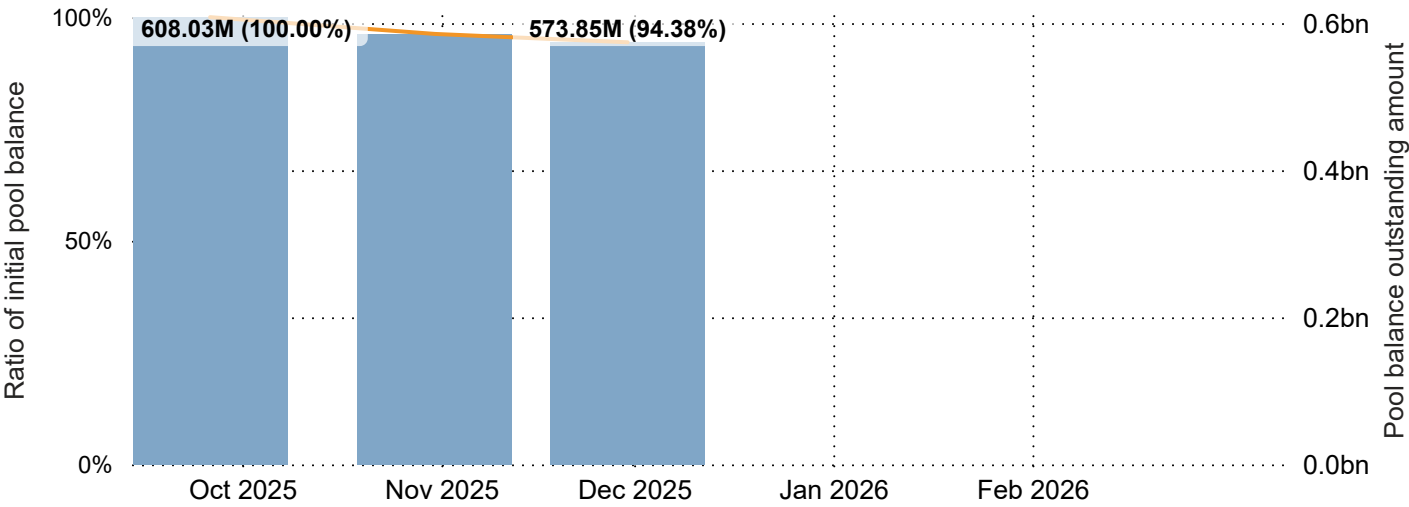

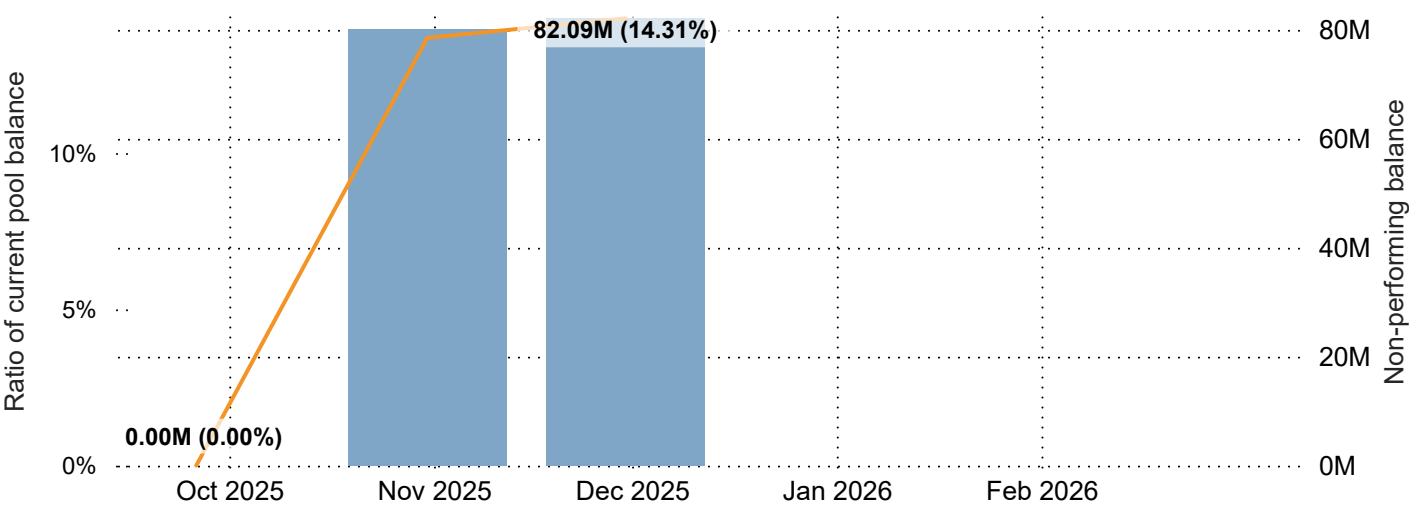
Asset pool balance (currency : EUR)

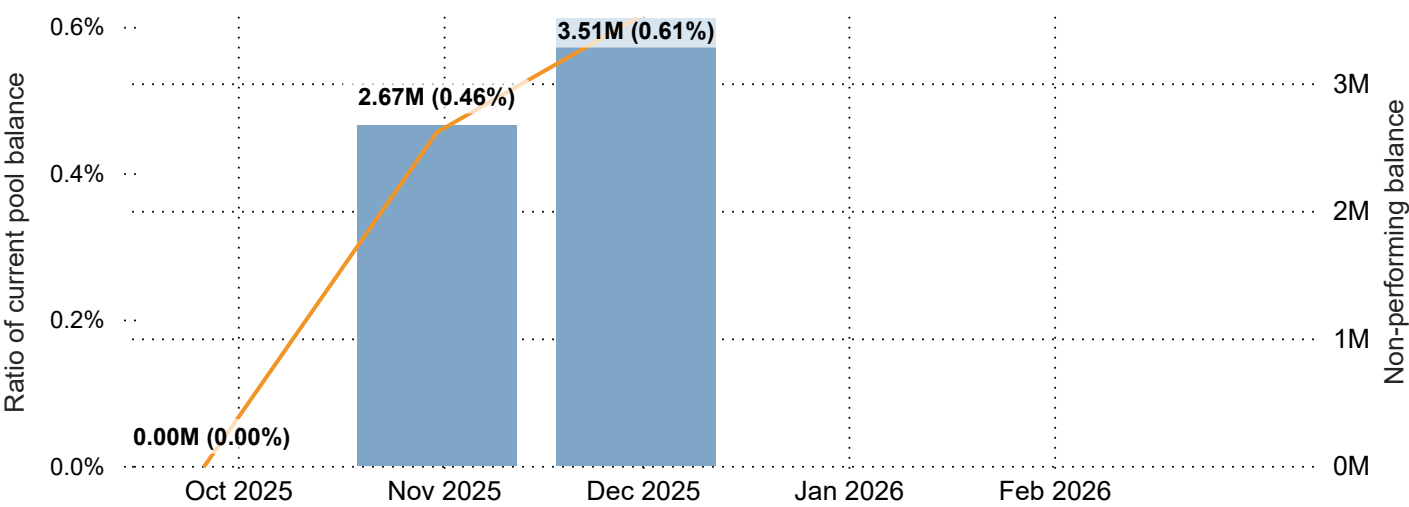
Non-performing balance due for more than 30 days in arrears (currency : EUR, default : 8M)

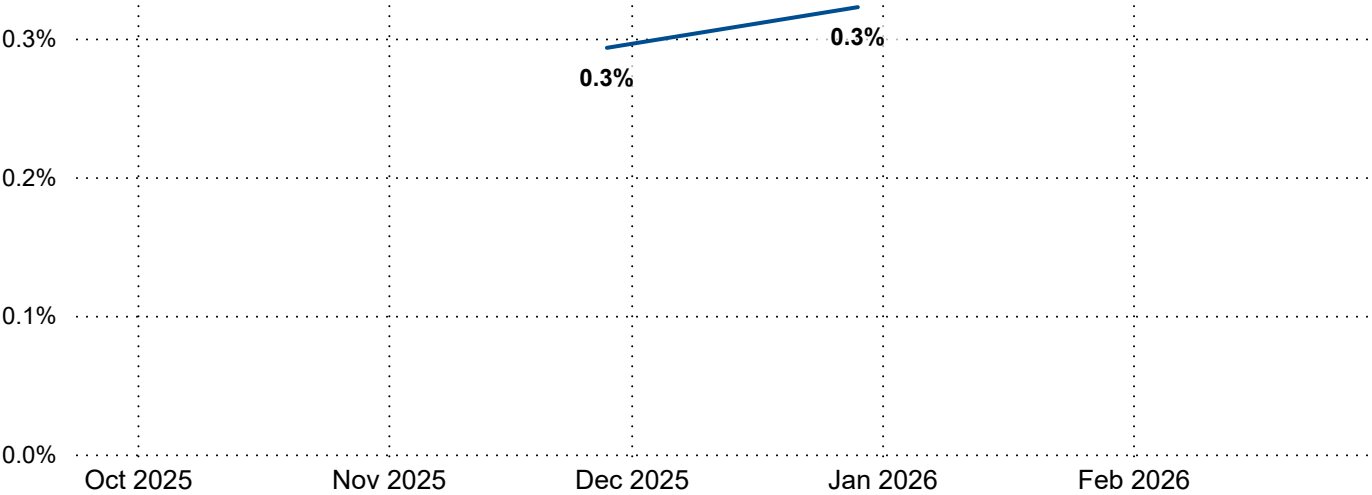

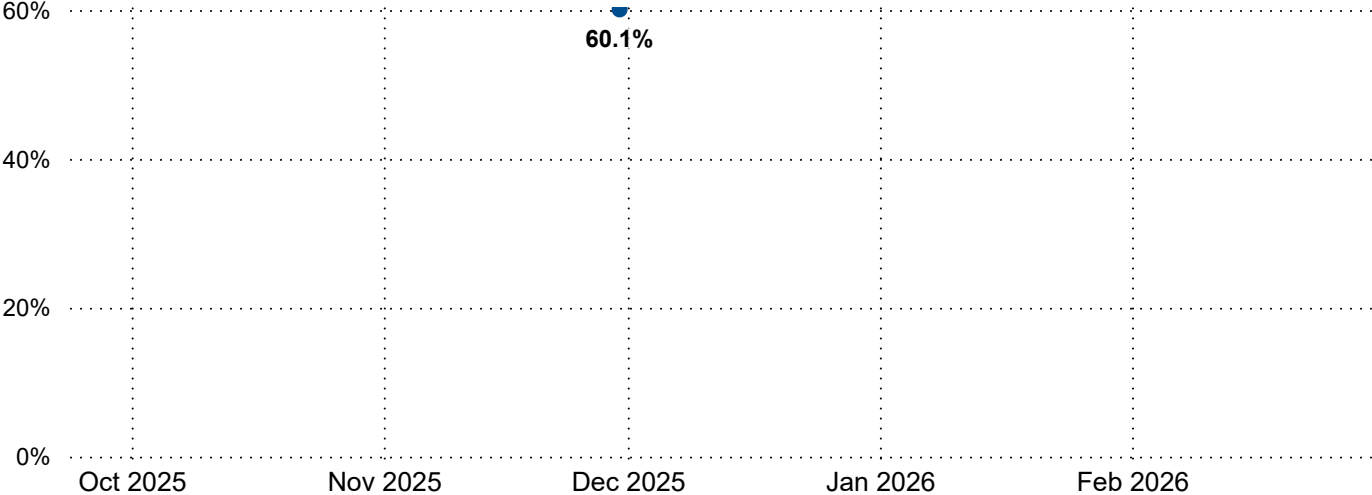
Cumulative default ratio (default : 8M)

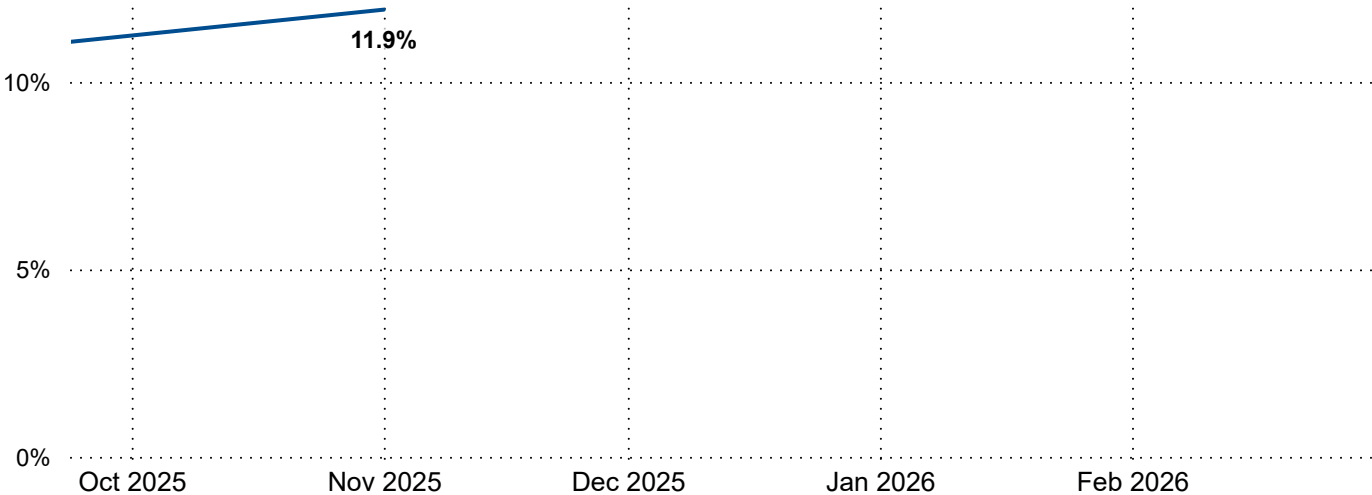
Cumulative recovery ratio (default : 8M)

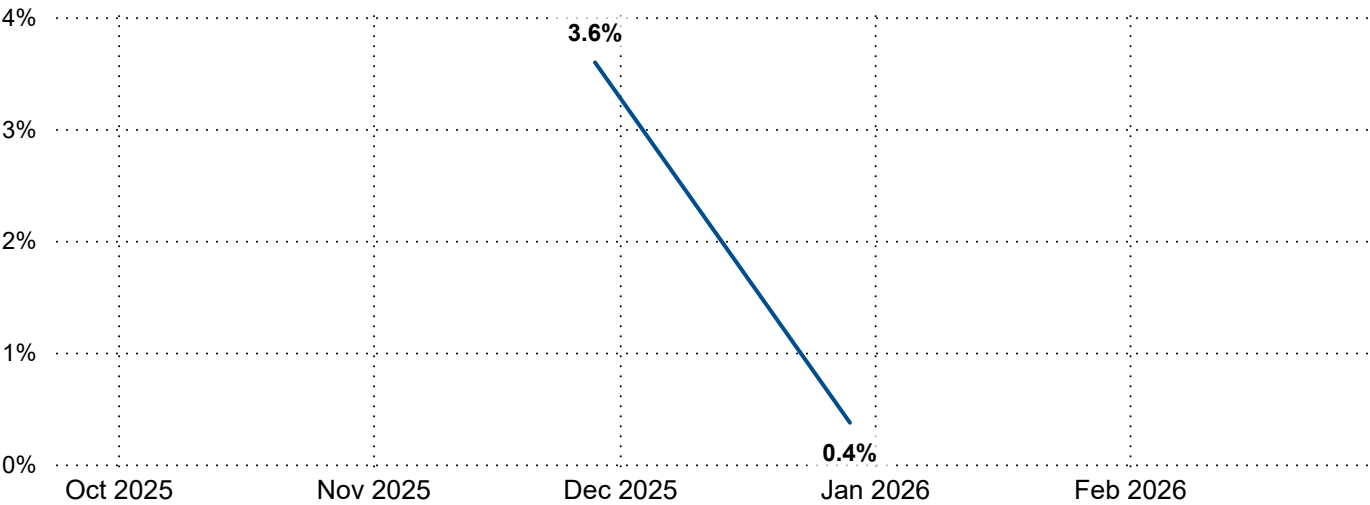

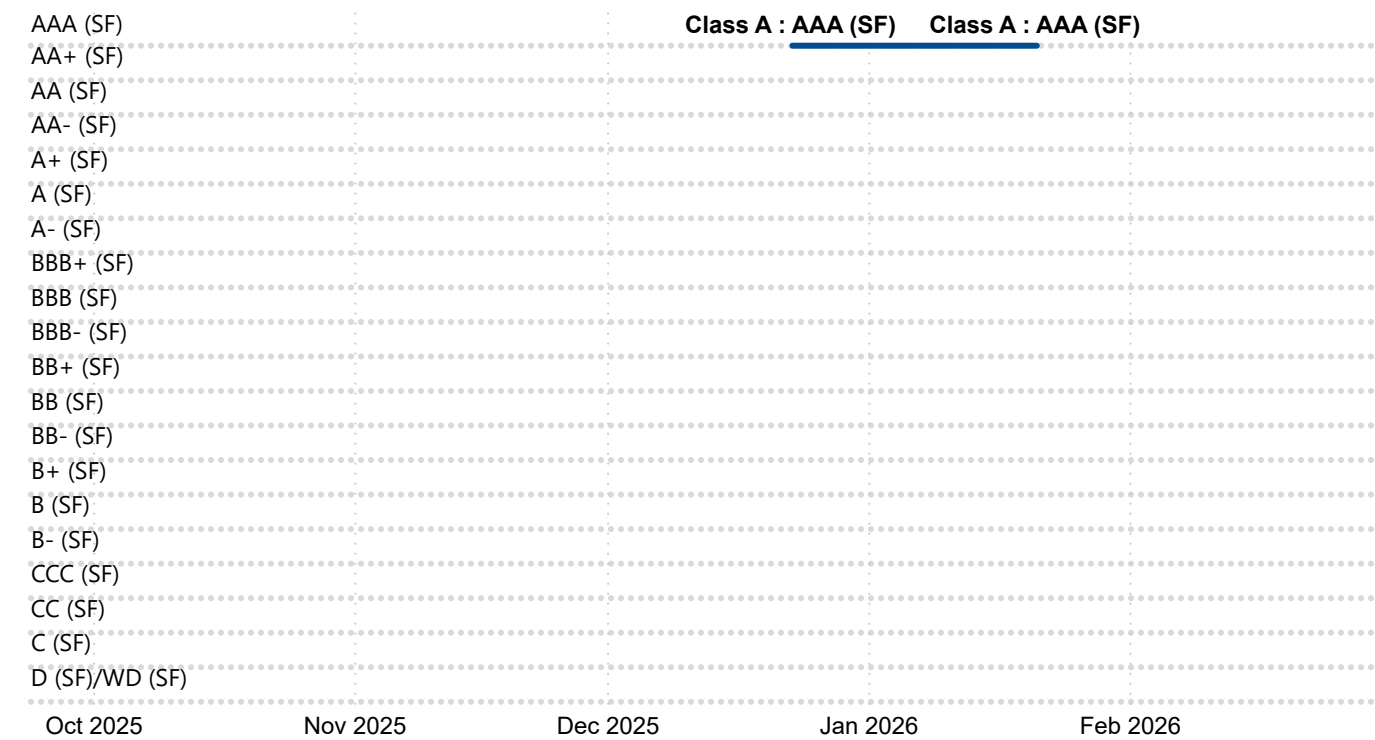

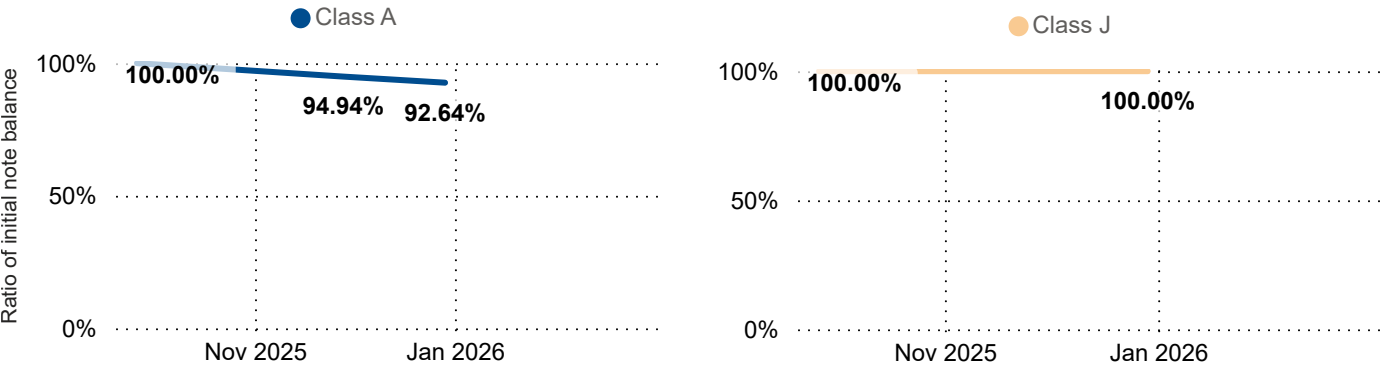

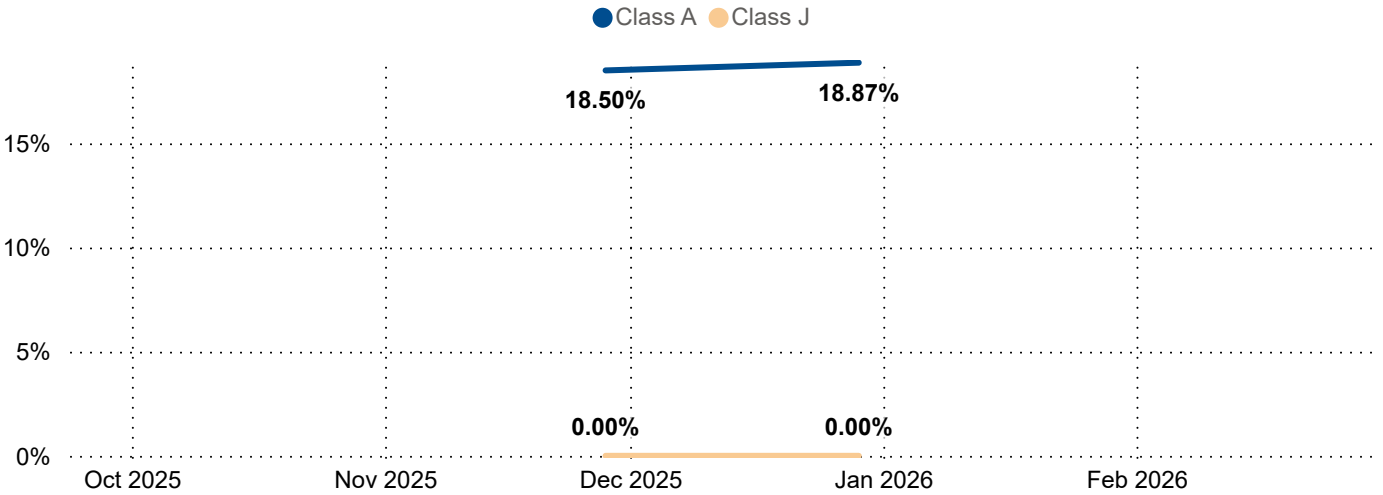
Outstanding notes balance

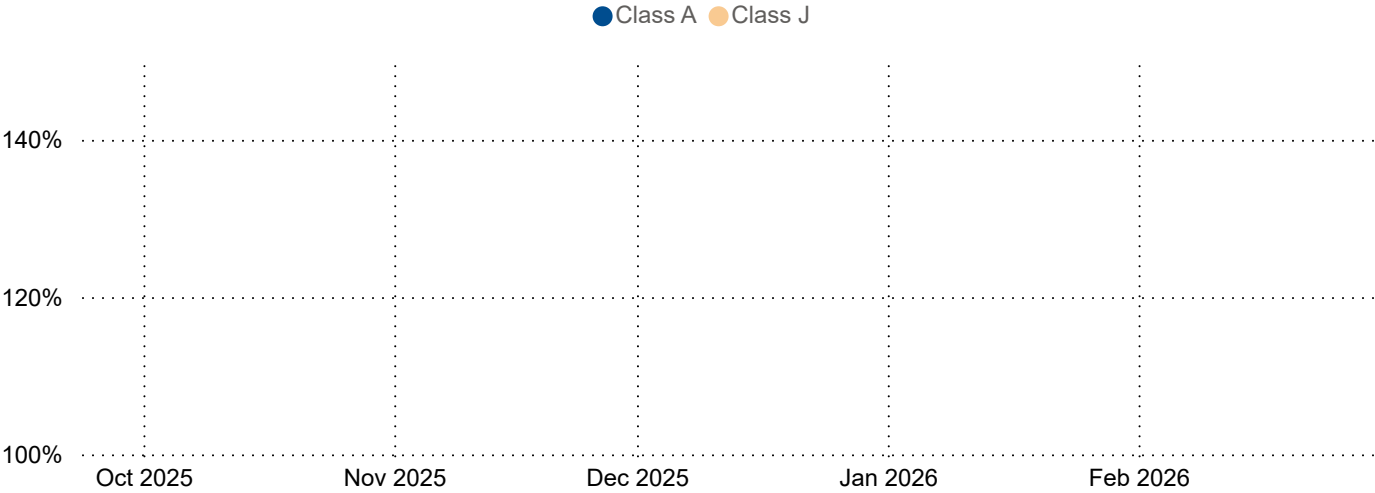

Field name	Description
