



### Asset pool balance (currency : EUR)




### Non-performing balance due for more than 30 days in arrears (currency : EUR)





### Cumulative default ratio (default : 8M)






#### Cumulative recovery ratio (default : 8M)



### Annualised constant prepayment rate (CPR)








